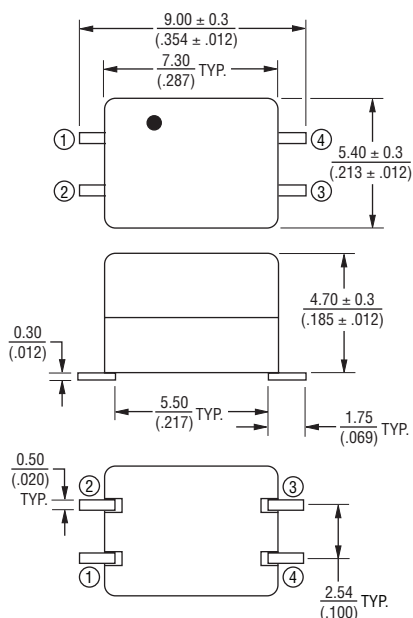

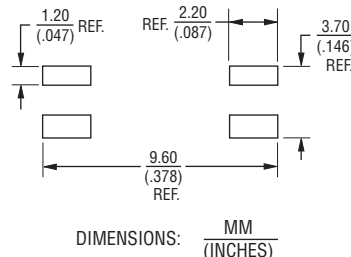

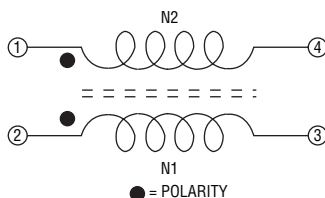
Product Dimensions

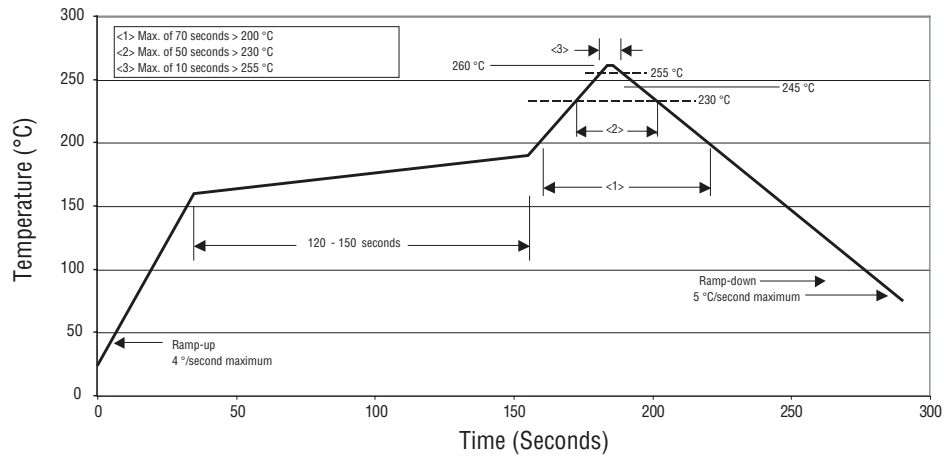

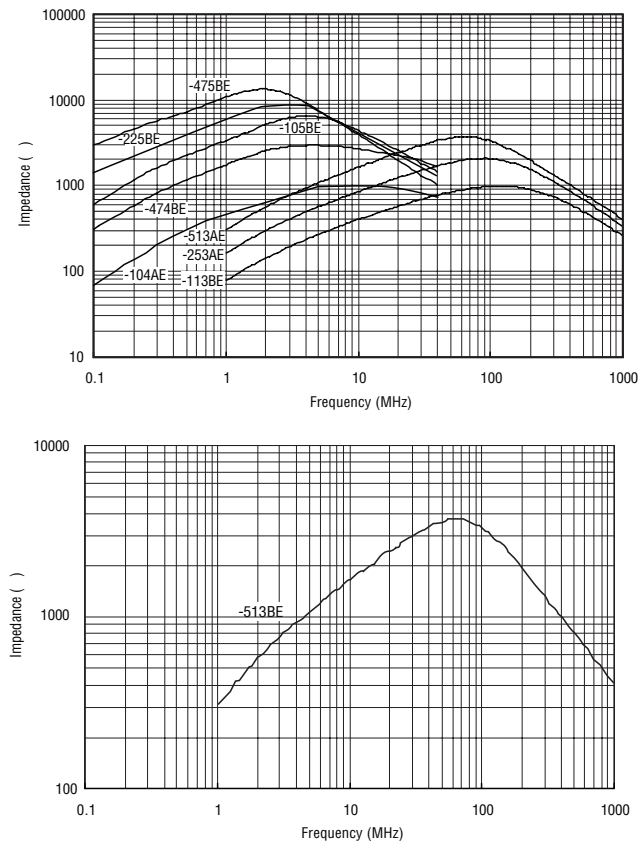

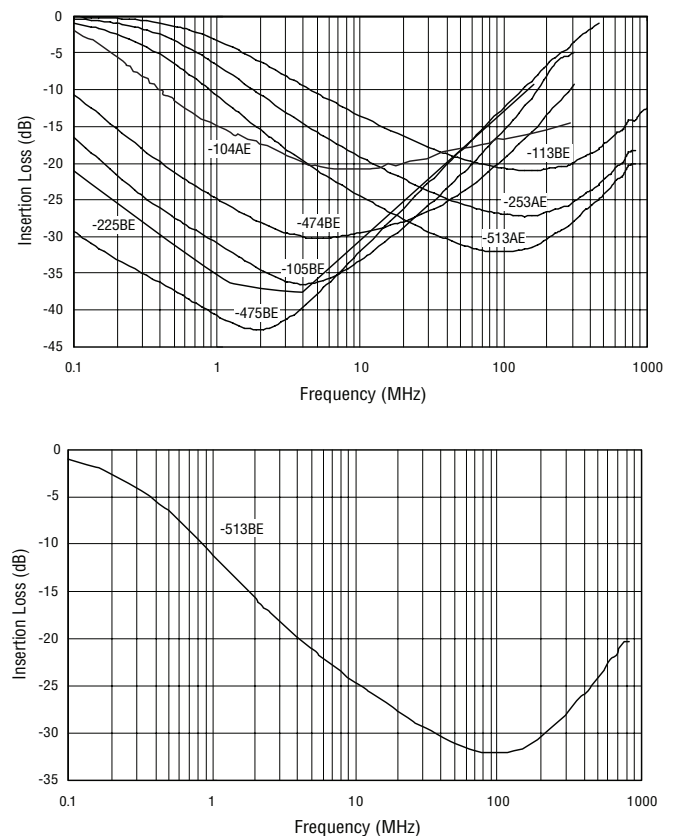
Solder Profile

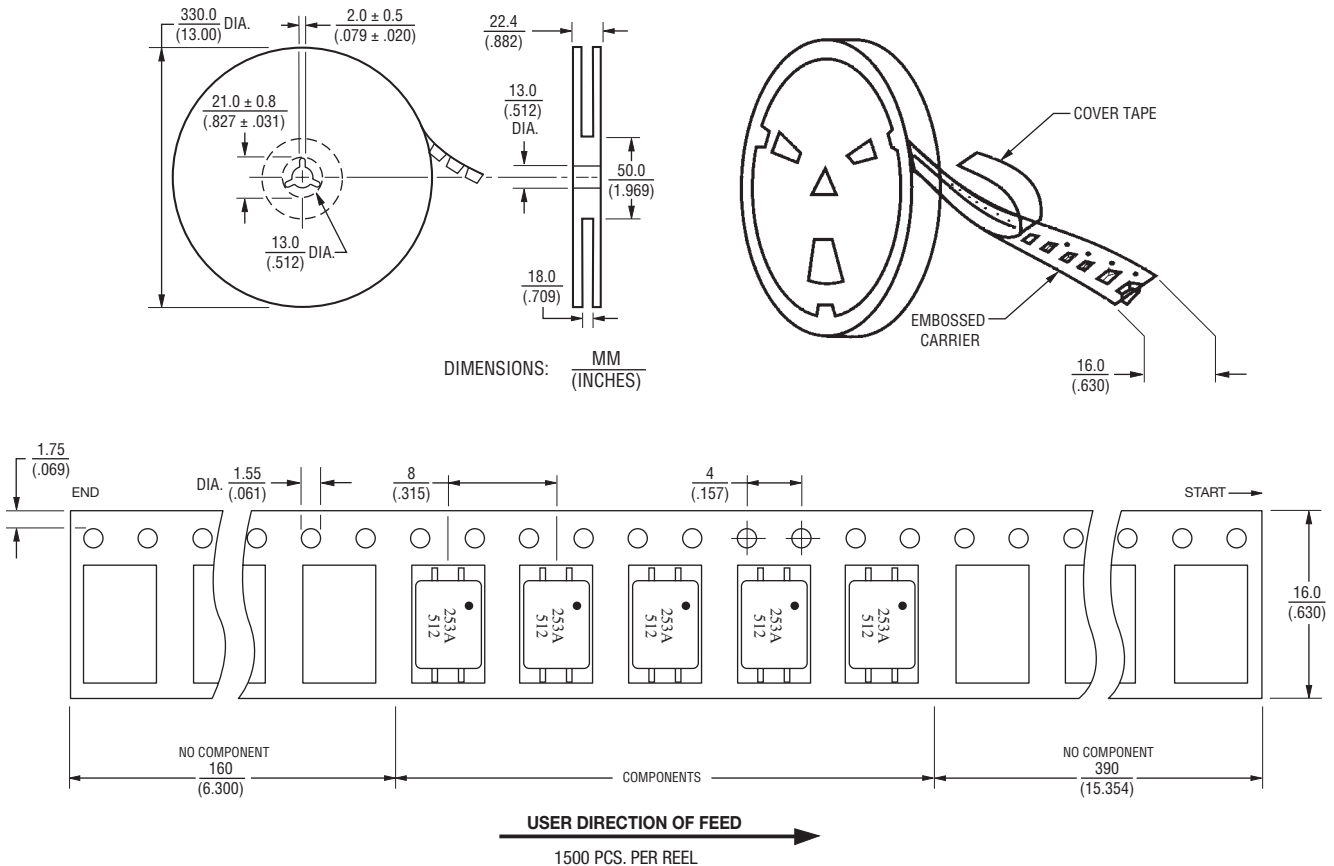
